RE: Mt. SAC Physical Education Project (PEP) Status

Dear Mr. Nellesen,

On May 15, 2017, a "Stop Work" notice was issued to Mt. SAC as it relates to the lack of grading and building permits for work being performed for the Mt. SAC Physical Education Project (PEP), formerly known as the "Hilmer Lodge Renovation Project." As a reminder, the Stop Work notice remains in full force and effect, and Mt. SAC does not have the necessary authorization(s) to perform any earthwork or grading related activities without a City grading permit. For your reference, attached is a copy of the May 15, 2017 Stop Work notice.

Further, the City has judicially challenged Mt. SAC's determination exempting the PEP from the City's land use and zoning authority in addition to challenging the adequacy of Mt. SAC's CEQA documentation and findings. In an effort to facilitate the settlement negotiations that would have resolved the pending litigation, the City undertook an initial review of the August 15 submittal and determined that it was incomplete. However at this time and absent resolution of the pending litigation, review of the submitted August 15, 2017 grading and truck haul route plans will not begin plan check until all entitlements have been obtained in accordance with the City's Zoning Ordinance and CEQA.
